### Time to file for **FEMA** aid ends

Phelps and Pulaski County residents have until July 29 to request disaster assistance under an extension granted by the Federal Emergency Management Agency.

Homeowners, renters and business owners who suffered damage as the result of the severe storms, tornadoes and flooding in a number of Missouri counties designated for federal and state assistance must register by that date.

The assistance is for any damage between the dates of April 19 and June 6. This covers the tornadoes in the Joplin and Sedalia areas and the flooding in southeast Missouri.

Phelps and Pulaski are among 25 counties designated for individual assistance under the presidential disaster declara-

"The July 29 deadline is coming up quickly," said Federal Coordinating Officer Libby Turner. "If you know someone who was affected by these events, please encourage them to take a few minutes to register with FEMA and learn how we can help them."

Residents in Phelps and Pulaski who have registered have already received \$55,000, said John Mills, FEMA external affairs field specialist.

Mills estimated that the Joplin area had received \$16 million and that the state of Missouri had received \$29 million thus

## \$286,942 in unpaid bills

City Administrator Alan Clark requested that the city remove unpaid utility accounts from the books at the St. Robert Board of Aldermen meeting Monday night.

The utility accounts represent the unpaid ones from 2003 through January of 2008.

Some aldermen expressed concern that wiping these unpaid bills off the books would mean accepting a loss on the unpaid bills.



Mayor Pro Tem Todd Williams said, "We're just making them inactive, we can still go after them."

Ward Two Alderman Ed Spotts asked, "We are specifically going

The board discussed the use of collection agencies to try and recoup some of the loss the city is taking on the unpaid bills.

Clark told the board that the option had been discussed and looked into, but "there's nobody out there that wants to do it."

City Attorney Tyce Smith suggested that the city take bids from collection agencies and try to collect on the larger accounts.

He said he knew of a "couple"

after these people for what they that the city could request bids

Collection agencies usually go after the person or people responsible for an unpaid bill and give the entity that the bill was originally owed a certain amount on the dollar such as \$0.25.

The collection agency and the entity agree upon that price before the collection agency begins trying to collect on the bill.

Collection agencies can get ex-

#### Meal prices set for 2011-12

Board approves policies

The Crocker School Board approved the breakfast and lunch prices for the 2011-12 school year.

Breakfast will cost students in kindergarten through 12th grade \$1.10. Elementary lunch will be \$1.45, middle school lunch \$1.55 and high school lunch \$1.65.

The board also approved keeping the gate admission the same as the 2010-11 school year and will be as follows: basketball, softball and baseball, \$3 for adults, \$1 for stu-

The school will get a new Damtronics Information Sign at a total cost not to exceed \$24,551, including \$19,551 for the actual sign.

The sign must be a "turn key" project with confirmed warranties.

In other news, the board approved the Comprehensive School Improvement Plan, 2011-12 bus routes, BBFA Board Member Conflict of Interest and Financial Disclosure policy and spending \$12,240 on a diesel Grasshopper mower from Crown Power and Equipment, Eldon.

On Aug. 23 there will be a tax rate hearing at 6 p. m. prior to the regularly scheduled monthly board meeting.
