When the *Daily Guide* didn't receive a reply to the initial e-mail, another e-mail was sent on April 15 with the same questions.

Mayor Bob Wall replied on April 18 to the *Daily Guide's* questions with the following statement, "The City of Richland is licensed and inspected by the Missouri Department of Agriculture and has passed all inspections without violations."

Another e-mail was sent in reply to this statement asking if the city would answer the questions and the *Daily Guide* received no reply.

Lucy Hensen was sworn in as mayor at the city board of alderman meeting on Tuesday, April 19, and City Administrator Anita Ivy was fired at that same meeting.

Tuesday, April 19, another e-mail was sent to the mayor's office with additional questions.

A phone call also was made to the mayor's office on April 20 and no reply was received.

Two more phone calls were made to the mayor's office on April 22 and Mayor Lucy Hensen requested some time to look into the matter. No reply has been received from the Mayor's office since that time.

Bill removes hurtful terms from state law

A bill sponsored by freshman state Rep. Genise Montecillo to remove offensive and outdated phrases such as "mentally retarded," "mental retardation" and "handicapped" from all state statutes won final legislative approval Tuesday and was sent to Gov. Jay Nixon to be signed into law.

The measure, House Bill 648, passed without a dissenting vote in either the Senate or House of Representatives.

The bill substitutes terms such as "developmentally disabled," "developmental disability" and "disabled" for those removed from statute.
